True or False. In female or minor hockey, the determining factor for assessing a high sticking penalty is the height of the cross bar. (HC Rule 7.6)

Correct

- a) True. The cross bar never changes height so this is the best determinant.
- b) False. The shoulders of the offending player determines the height the stick may be for calling a high sticking penalty.
- c) False. The shoulders of the opponent determines the height the stick may be for calling a high sticking penalty.
- d) False. As of 2022, all high-sticking should be assessed as a head contact penalty.



What is the determining factor for the height of the stick for stopping play on a puck contacted by a high stick? (Hockey Canada Rule 6.9)

Correct

- a) The cross bar.
- b) The height of the opponent's shoulders
- c) The height of the shoulders belonging to the player who struck the puck with his stick



A27 is laying on the ice. The puck is 2 feet in the air and A27 knocks it down with her stick then her team mate takes possession of the puck. Should play be stopped due to a high stick of the puck? (HC Rule 6.9a)

Correct

- a) Yes, she struck the puck above her shoulders.
- b) No, for striking the puck the "normal" height of the shoulders is defined by where the player's shoulders would be if she was standing upright



standing upright.

True or false. After an AA or AAA team ices the puck; they may not change players. However, one team receives a penalty giving the other team a power play. Both teams may change despite the icing (HW SR-22).

Correct

- TRUE 
- FALSE, a power play does not negate the no-change icing rule.

A player elbows another player in the head. What penalty could be assessed? (HC Rule 7.6)

Correct

- a) a two-minute minor for elbowing.
- b) a minor, double minor, or Game Misconduct for elbowing.
- c) a minor, double minor, or 5 + Game Misconduct for Head contact.
- d) Use head contact as elbowing is no longer a signal or a call starting in Fall 2020
- e) both c & d are accurate. 

B13 is in team A's goal crease. B4 shoots the puck on net and B13 deflects the puck for a goal. The referee waves off the goal as B13 preceded the puck into the crease and had an effect on the play. Where does the next face-off go? (Rule 6.3e, iv, HC Rule Book)

Correct

- a) Team B's end zone face-off.
- b) At a neutral zone dot outside of team A's end zone. 
- c) At a neutral zone dot outside of team B's end zone.
- d) Team A's end zone face-off.
- e) Center ice.

Team A ices the puck, but icing is incorrectly not called. Team A scores a goal. The liner informs the referee that icing should have been called. The referee disallows the goal. Where does the next face-off take place? (Hockey Canada 4.15e)

Correct

- a) Center Ice for an error on an icing call.
- b) In Team B's end as though the goalie covered the puck.
- c) In Team A's end, just the same as if icing had been called since this would be the correct call.



It is a 2-1 game, A6 has a breakaway with 5 seconds left and is fouled from behind (meeting all criteria for a penalty shot) with the next stoppage happening at 0:00 horn. What should the referee call? (HC Rule 4.11d)

Correct

- a) Nothing if this is the end of the game, a penalty shot if this is the end of the first or second.
- b) A penalty shot because it is a 1 goal game, nothing if it is a 2 goal or more lead.
- c) A penalty shot must be awarded regardless of whether this is the end of the first, second, third, or overtime period.
- d) Nothing regardless of which period this is.



What is the signal for "too many players on the ice"? (P. 3 of HC Rule Book)

Correct

- a) downward pointing finger making a circle
- b) flat palm in front of the face
- c) six fingers (one hand open plus pointer finger on other hand) in front of the chest
- d) the number of fingers indicating the number of players on the ice



What options does the referee have regarding a slew foot? (HC Rule 8.8)

Correct

- a) 2+2+GM or Match
- b) 2+2 or a Match
- c) Match for all slew foots
- d) Major + Game Misconduct
- e) a or d
