During a game, an official calls a Gross Misconduct under Section 11 for something that was said. Who should write up the game report? (There is no resource for this answer...but think about who has the best description of the event)

Correct

- a) If the three-offical system then the referee
- b) if the three-official system then the linesperson
- c) If the two-official system then the more senior of the two officials
- d) for either system, the official who assessed the penalty
- e) either b and c depending on the system



In the two official system, a penalty occurs in the attacking zone. Which official is allowed to call the penalty? (this is not clearly written anywhere, but page 4-6 of the HCOP manual (HWRD Resources Page) has a note that implies the best answer) .

Correct

- a) The official in the attacking zone. The official at the blue line is responsible only for offsides or icings.
- b) either official can call any penalty anywhere on the ice at any time; officials work as a team to call penalties in the two-official system.
- c) The official at the blue line as she has a wider angle of view to the play



The whistle goes. What is the first responsibility of the linespeople in the three official system or officials in the two official system? (HCOP Manual 5-13)

Correct

- a) Retrieve the puck and set up the face off
- b) tackle the first player that misbehaves
- c) Create Presence...Ensure that the players are leaving wherever the play was stopped and proceeding to the bench or face-off dot without any altercations
- d) Let your partner (two official system) or the Referee (in the three official system) talk the players out while you watch from the top of the circles to help with penalty calls.



When dropping the puck, where is the official's free hand? (HCOP 3-5)

Correct

- a) behind her back
- b) in front of her stomach
- c) at her side
- d) any of the above



During an altercation in the two-official system, what does the official who whistled the play down do? (HWRD Resources: HCOP 4-5)

Correct

- a) get in there and break it up.
- b) retreat to the penalty bench to report penalties to the timekeeper immediately.
- c) take up a position to see the players involved, the other players, and the benches (similar to a position taken by the referee in the 3-official system) while also being close enough to talk the players out of the scrum.
- d) remove all the players that are not "fighting" to their benches (goalies stay in their creases) using your voice and physical presence



In the three official system, during a penalty shot, the referee and one linesperson take up positions in the end zone. Where does the linesperson in the end zone position herself? (HCOP 4-10)

Correct

- b) same side as the referee; at the top of the circle
- c) opposite side of the ice from the



c) opposite side of the ice from the referee; in a similar position but a little further away from the net



d) opposite side of the ice from the referee; at the blue line

How close should the linesperson (or referee in the neutral zone in the 2-official system) stay to the boards during the play? (HWRD Resources, HCOP 5-2)

a) With his body touching the boards

b) no further than 6 inches off the boards

c) no further than 3 to 5 feet off the boards



d) no further than 10 feet

In leagues using two linespeople, with no-change icing, which official is in the best position to stop the offending team from changing? (The How-To of No-Change Icing found in HWRD Resources-Procedures)

Correct

Referee

Back linesperson who initiated the icing



Front linesperson who is stopping play

According to "Perspectives-How to call a penalty" (Found in HWRD resources-procedures of wpgrefs.com) how long does the referee wait to signal a penalty after stopping play?

Correct

Do not wait, start your penalty call as soon as you stop play.

Wait three seconds to let the entire arena focus on you.



Wait three seconds to remember your call.

Wait ten seconds.
